With reference to the above mentioned application, Development Commissioner, Kandla Special Economic Zone is pleased to extend to you all the facilities and entitlements admissible to a unit in a Special Economic Zone subject to the provisions of the Special Economic Zones Act, 2005 and the rules and orders made there-under and for the establishment of a unit at Kandla Special Economic Zone for undertaking authorized operations, namely, Trading Activity as under:-

This approval is subject to following terms & conditions:-

- (i) You shall export the goods manufactured/goods imported/procured for trading and services, including items of trading, as per provisions of the Special Economic Zones Act, 2005 and Rules made there-under for a period of five years from the date of commencement of authorized operation. For this purpose, you shall execute the Bond - cum - Legal Undertaking as prescribed under the Special Economic Zone Rules- 2006.
- (ii) You shall fulfil the pollution control requirements, as may be prescribed by the Pollution Control Authorities.
- (iii) You shall achieve positive Net Foreign Exchange (NFE) as prescribed in the Special Economic Zone Rules, 2006 for the period you operate as a unit in the Special Economic Zone from the date of commencement production / activity, failing which you shall be liable for penal action under the Foreign Trade (Development and Regulation) Act, 1992.
- (iv) You may import or procure from the Domestic Tariff Area all the items required for your authorized operations under this approval, except those prohibited items under the ITC (HS) Classifications of Export and Import items.
- (v) You may supply/sell goods or services in the Domestic Tariff Area in terms of the provisions of the Special Economic Zones Act, 2005 and Rules and orders made there under.
- (vi) This Letter of Approval is valid for a period of one year from its date of issue. You shall implement the project and commence production within one year period or within such period as may be extended.
- (vii) Date of commencement of Authorized Activity shall be intimated to the Development Commissioner.
- (viii) This Letter of Approval shall be valid for a period of five years from the date of commencement of authorized activity.
- (ix) The approval is based on the details furnished by you in your project proposal/application.
- (x) You shall abide by the provisions of Special Economic Zones Act, 2005 and the rules and orders made there-under.



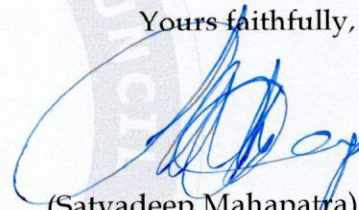

- (xi) You have the option to renew the approval or exit in terms of the Special Economic Zones Act, 2005 and the rules and orders made there-under.
- (xii) You shall confirm acceptance of the above terms and conditions to the Development Commissioner within forty five days of issue of this Letter of Approval.
- (xiii) If you fail to comply with the conditions stipulated above, this Letter of Approval shall be cancelled as per the provisions of the Special Economic Zones Act, 2005 and the rules and orders made there-under.
- (xiv) All future correspondence including for amendments / changes in terms and conditions of the Letter of Approval or for extension of its validity shall be addressed to the Development Commissioner.
- (xv) You shall not import second hand materials such as used/ worn cloths, plastic scrap or any other second hand used goods. You may import or procure from the Domestic Tariff Area all the items required for your authorized operations under this approval, except restricted/prohibited. No harmful materials shall be allowed to bring inside the Zone. No second hand goods such as worn and used clothing, plastic scrap, prohibited, canalized item and any other second hand used goods will be allowed to be stored in the said premises.
- (xvi) You shall register themselves with NSDL for SEZ online services and obtain RCMC from EPCES for availing exemptions, drawbacks and concessions under the SEZ law.
- (xvii) You shall obtain Clearance from any other agency and any permission/license required under any other law in respect of above activities shall be complied with before commencing the said activity.
- (xviii) None of the items which are restricted or prohibited will be allowed to be trade and any restrictions on import/export of any items will apply unless specifically permitted by the UAC.
- (xix) You shall strictly follow the norms of concerned State/ Central Act for storage/ handling of Hazardous materials.
- (xx) In case of any discrepancy/mismatch between the above ' Description of Goods' as provided by the unit & Description of goods as per DGFT Import Policy, the later will be prevail.



- (xxi) Further, the items will be subjected to Policy conditions specified in DGFT ITC Hs code wherever applicable.
- (xxii) Any restrictions on import/export of trading items will apply.
- (xxiii) For all services, Provisions of Section 2(z) of the SEZ Act, 2005 shall be applicable.
- (xxiv) Further, with respect of Trading items mentioned at Sr. No. 12 to 16 of Annexure-I is for 100% export only.
- (xxv) Notwithstanding to this approval of LoA, if the DC Office/Approval Committee notices any pending legal proceedings as on date of decision of the Committee or any legal proceedings that may be initiated after the decision of the Committee against the unit/firm/company and/or its Proprietor/Partner /Director, which has a bearing on the decision taken/LoA granted to the firm in any manner, the LoA granted will be liable for action, including cancellation under the FT (D&R) Act and necessary action will be taken against the unit in terms of applicable provisions of law.
